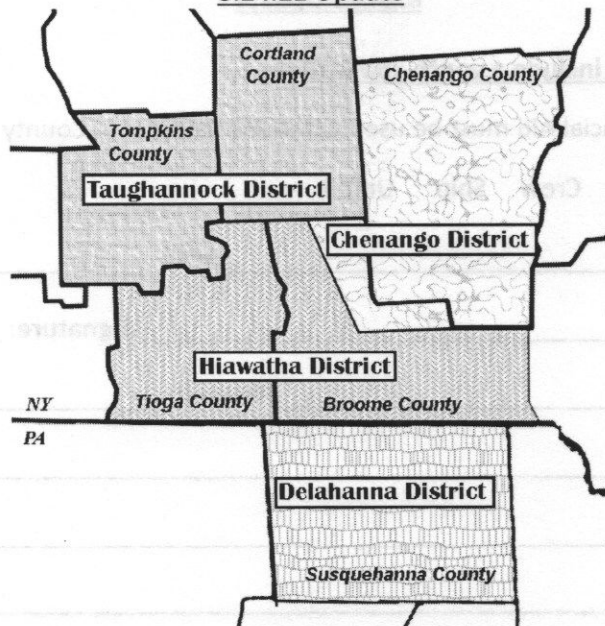

WHO
